## Background

Commercial vehicle operator safety certification is a priority across Canada. While this case study focuses on [Ontario's Commercial Vehicle Operator's Registration \(CVOR\) program](#), provinces and territories use different regulatory frameworks—including Safety Fitness Certificate programs—to achieve the same goal: ensuring commercial carriers meet regulatory and safety requirements.

## The Challenge

As part of Ontario's digital modernization strategy, the Ministry of Transportation sought to transform the CVOR certification process. Historically, new CVOR applicants were required to complete an in-person knowledge test at DriveTest centres, creating accessibility challenges, administrative overhead, and barriers for operators across the province.

The Ministry required a secure, scalable, and accessible online solution capable of supporting province-wide delivery while maintaining consistent regulatory training and assessment standards.

**Challenge:** In-person testing created accessibility barriers and administrative burden for carriers.

**Launch:** Ontario replaced the in-person CVOR knowledge test with the mandatory online learning on November 1, 2024.

## Launch

Beginning on November 1, 2024, Ontario replaced the traditional in-person CVOR knowledge test with the mandatory Online Learning & Assessment Program for all new applicants.

The tailored eLearning and SkillsPass-powered delivery solution modernized the certification experience by replacing an in-person testing model with a flexible, digital-first approach that improves accessibility for commercial vehicle operators while supporting Ontario's broader service modernization objectives.

## Outcomes

The program's early results demonstrate how purpose-built online learning can transform the delivery of mandatory transportation safety training at a province-wide scale.

- » **11,000+** carrier organizations (owners/managers) and drivers have completed online CVOR training since it launched.
- » **85%** learner completion rate, demonstrating strong engagement with the content.
- » **15%** of learners completed training from outside major urban centres, improving access while reducing travel time and costs for rural carriers.
- » **88%** overall learner satisfaction rating and willingness to recommend the program.
- » **96%** of learners said they would certainly apply what they learned to their business practices.
- » **98%** of owners/managers indicated the online training would serve as a valuable ongoing reference resource.

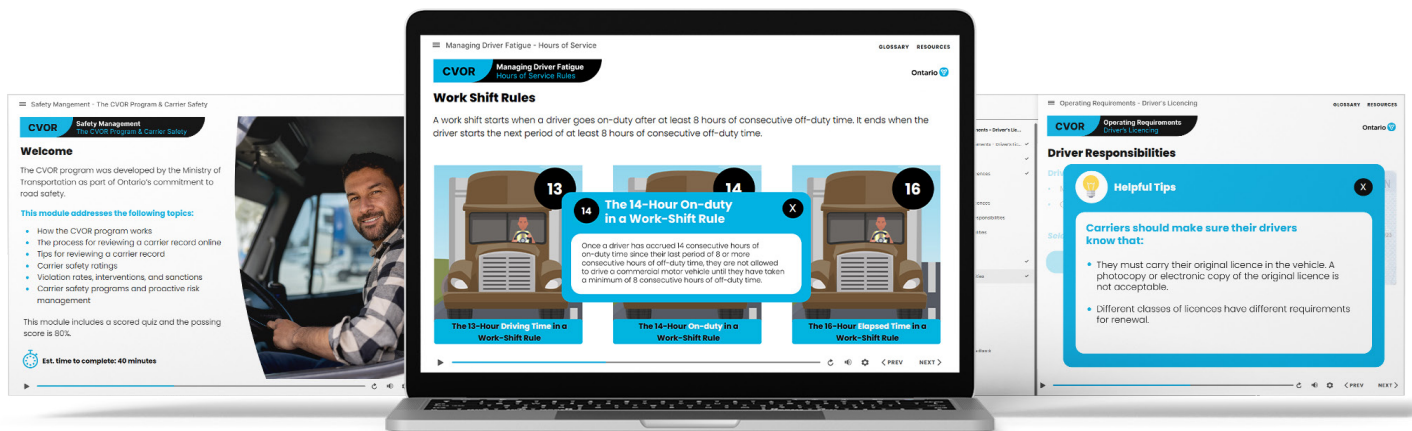

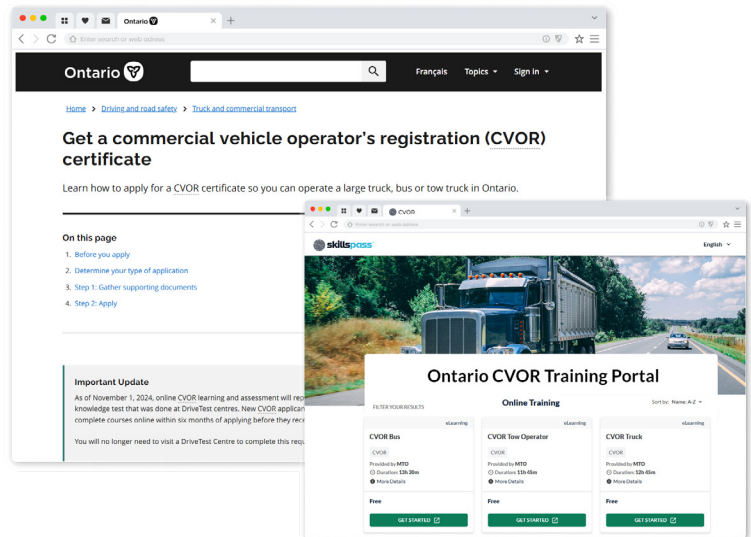
